Attapulgit (palygorskite fibers) is a hydrated magnesium aluminum silicate. Long palygorskite (attapulgit) fibers (>5 micrometers) are possibly carcinogenic to humans (Group 2B). Short palygorskite (attapulgit) fibers (<5 micrometers) cannot be classified as to their carcinogenicity to humans (Group 3). The attapulgit present in this product contains fibers 0.5-2.5 um range, so would be considered by IARC as Group 3.
